What is a Community Wildfire Protection Plan (CWPP)?


- Provides an updated hazard assessment for an area
- Creates a list of next-step actions and priorities
- Opens doors for funding
- Shift wildfire prevention, response, and recovery culture

Minimum requirements

Local and regional collaboration

Identify and prioritize areas for wildfire risk reduction projects

Identify strategies for reducing structural ignitability



San Benito CWPP Update

- Guidance recommends updates every 5 years
- Prior CWPP published in 2010 lots has changed!
- ✓ More fires burning more land
- ✓ Hotter and drier conditions
- ✓ More people causing more ignitions (accidental and intentional)
- √ 100+ years of fire suppression → more dense, burnable vegetation

- Update will include:
 - Updated definition of wildfire risk in San Benito County
 - Recommendations to reduce risk
 - Prioritized actions and projects
